



153-B (Imputations, assertions, etc., that any class or persons cannot, by reason of their being members of any religious group or caste, or community, etc., bear true faith and allegiance to the Constitution of India or up-hold the sovereignty and integrity of India) and Clause (b) and (c) of sub-section (1) and sub-section (2) of section 505 of the Indian Penal Code, 1860 (45 of 1860).




