These powers will be exercised subject to the condition that the budget provision exists and with due regard to any general restrictions, scale or limits as are prescribed by the Govt. of India in this behalf in the Fundamental Rules, Supplementary Rules, General Financial Rules and Delegation of Financial Rules, 1958 and other administrative orders issued from time to time.
