- a) They shall be required to deposit earnest money with each tender as per terms and conditions of the Notice Inviting Tenders. 3.
 - b) Security Deposit will be recovered from their/his bills in accordance with the rules in force
- They shall employ the required technical staff and/or tools and plants as per terms and conditions of each contract/agreement. 4.
- They shall have to abide by the terms and conditions of the NIT/contract/agreement as they stand or as may be altered from time to time.
- They shall have to apply to the Works Contract Cell of the area in which they are assessed for grant of Sales Tax Clearance Certificate.
