PRESS TENDER NOTICE NO. 3/F.O. to Dir. (M.M.)/2009-10

Sealed item rate tenders are invited for the following work on PWD-8 form by the Executive Engineer, Store Division No. I, DDA, G.T. Karnal Road, Azadpur, Delhi upto **3:00 P.M.** on **14.12.2009** on behalf of DDA from the contractors who have worked in DDA, CPWD, MES & P&T and meet the following conditions, which shall be opened on the same day at **3:30 P.M.** by Ex. Engineer, Store Division No. I, DDA at Vikas Sadan Press Building near INA Market, New Delhi in the presence of intending tenderers or their authorized representatives.

1. The contractor must have executed the work of similar nature i.e. unloading of Railway wagons/ containers filled up with cement bags in the time schedule given by Railways, stacking and carriage of the same to the godowns and having their own fleet of trucks and worked in either of above organizations.
2. The contractor should submit the certificate/ certificates of the satisfactory completion/ performance of at least two works of similar nature/ class during the last five years costing not less than **50%** of the estimated cost (Gross).

The tender documents can be obtained on any working day from the Divisional Office between **11:00 A.M.** to **3:00 P.M.** on payment of cost of tender (non refundable) as well as submission of required certificates. Sale of tender forms will be stopped four days (including the date of opening) before the date fixed for the opening of tender i.e. on **17.12.2009**.

The manner of submission of tender, opening of the same and entry of the contractor/ their authorized representatives to the place of opening shall be as provided in Clause-3 (a), (b) and (c) of PWD-6 forming part of the tender documents.

The tenders shall be accompanied with earnest money in cash (up to **Rs. 10,000/-** receipt/ Treasury Challan/ CDR/ FDR/ DD of a scheduled Bank issued in favour of Executive Engineer, SD-I. **50%** of the earnest money or **Rs. 20.00 Lac**, whichever is less, shall be in the form prescribed above and balance can be accepted in the form of bank guarantee issued by a scheduled bank.

Note: Conditional tenders shall be rejected.
