- 3. The manner of submission of tenders, opening of the same and entry of contractors/ their authorized representatives at the place of opening shall be as per Class-3 (a), (b) & (c) of PWD-6 forming part of the tender.**

Earnest Money shall be in Cash/Receipt Treasury Challan/Deposites at call receipt of a Scheduled Bank/Fixed Deposit Receipt of a Scheduled Bank/Demand Draft of a Scheduled Bank issued in favour of ACCOUNTS OFFICER, CAU (CWG) DDA.** In case, the amount of earnest money is more than **Rs.5 Lacs**, part of Earnest Money is acceptable in the form of bank guarantee also and in such cases minimum 50% of earnest money (But not less than **Rs. 5 Lacs**) shall be deposited in the shape as described above and for balance amount of earnest money bank guarantee will also be acceptable in favour of **ACCOUNTS OFFICER, CAU (CWG) DDA.**
