 Similar works means Civil works of approached of RUB or construction of Bridge. For the purpose of Pre-Qualification the cost will be taken as Rs.4.65 crores.  
 b) **Turnover:** Average annual financial turnover 50% of the estimated cost put to tender during the immediate three consecutive financial years.  
 c) **Profit /Loss:** Should not have incurred any loss in more than two years during the five years ending 31<sup>st</sup> March, 2009.  
 d) **Solvency Certificate:** The contractor should have Bank Solvency of the amount not less than 2 crores.  
 The tenderer should be registered under Delhi Value Added Tax Act 2004 and he will submit a valid "No Dues Certificate" from concerned authority along with application for issue of tender or submit an affidavit that up to date returns have been filed and agency has no dues towards the sales tax/value added tax department. He will also give the copies of all returns filed in the sales tax department.
