Sealed item rate tenders are invited for the following work by the Ex. Engineer (E), Elect.Divin.No.5/DDA, Central Nursery, Sector-5, Dwarka Ph.I, N. Delhi up to 3.00 PM on 12-01-10 on behalf of DDA from the approved contractors and eligible contractor of DDA, CPWD, Railways, MES and P&T which shall be opened on the same day at 3.30 PM at Ground Floor, Vikas Minar, DDA Office I.P.Estate New Delhi in the presence of intending contractors or their authorized representative.

The enlistment of the contractors should be valid on the last date of sale of tenders.

In case only the last date of sale of tenders is extended, the enlistment of contractor should be valid on the original date of sale of tenders.

In case both the last date of receipt of application and sale of tenders are extended, the Enlistment of contractor should be valid either on the two date i.e. original date of sale of tender or on the extended date of sale of tenders.

The tender documents can be had on any working day from the office of CAU/Dwarka Zone/ Sale Counter Ground Floor, Vikas Minar between 11.00 AM to 3.00 PM on payment of cost of tender (non-refundable) mentioned against each works on production of valid Enlistment Registration Certificate and valid Registration with works contract cell of sales tax Deptt. of GNCTD and tax clearance certificate issued by the works contract cell in Form-XI. Sale of tender forms will be stopped 4 days (including the date of opening) before the date fixed for the opening of tender documents.

The manner of submission of tender, opening of the same and entry of contractors, their authorized representative to the place of opening shall be as provided in clause-3a(b) and (c) of PWD-6 forming part of the tender documents.

EARNEST MONEY: The earnest money should be Deposited alongwith tender documents in cash up to **Rs.10,000/-** only Receipts Treasury Challan/ C.D.R./ F.D.R./ D.D. of Scheduled Bank issued in favour of Sr.A.O./CAU/DWK Zone New Delhi. It should, however, be ensured that FDR / Pay Order is valid for a period of Six Months or more after last date of receipt of tender. The tender of the agency who does not enclose the earnest money in the prescribed manner shall be summarily rejected.



TERMS AND CONDITIONS

1. The work comprises of running & Operation of Sub. Pump sets and general lighting as per the inventory attached.
 2. The contractor shall depute the following staff under the contract.
 - a. Opererators- 3 Nos, One No in each shift. The Sub. P/sets shall be operated round the clock for water supply to U.G.R of sector 18-A Kargil houses Dwarka or as per direction of Engineer-in-Charge.
 - b. Wireman Gr.II shall attend the site of work between 9.00 AM to 5.00 P.M. at least once in a fortnight and as and when required.
 3. The contractor shall employ trained and competent staff to the satisfaction of Engineer-in-charge having two years experience of operation of pumps.
 4. The contractor shall supply the list of staff alongwith experience certificates to be engaged on the installation within 7 days of award of work. Engineer-in-charge shall have the right to reject any staff employed by the contractor.
 5. The staff employed by the contractor shall wear proper uniform and wear badges displaying their name and designation. The staff shall also be given photo -identity their name, Fathers name, Address, date of birth, Name of the agency with address and telephone No site for identity cards shall be given to the Engineer-in-charge within 15days of award of work.
 6. The contractor shall employ staff through out the period of contract i/c Saturday, Sunday Gazetted holidays and National holidays.
 7. Following records are to be kept at site of work
 - a. Printed log book ~~xxx~~ for recording operation.
 - b. Attendance register for staff employed.
 - c. Complaint/Inspection register.
- Note: The contractor shall get the registers authenticated from Engineer-in-charge before use at site.
8. The following minor maintenance i/c preventive maintenance shall be carried out by the contractor. The details of work carried out shall be recorded in the log book.

- a) H.R.C fuses shall be replaced as and when required.
- b) Replacement of rubber packing of valves and warnout nuts and bolts etc.
- c) Replacement of Fl. tubes incandescent and tube starters
- d) Checking and testing of starters, changeover switches main switches etc as and when required.
- e) Adjustment, alignment/tightening of nuts, bolts as and when required.
- f) Replacement of burnt out thimbles, wire thimbles etc.
- g) Daily cleaning of equipments/pump house.

Note: The material reqd for carrying out above jobs shall be supplied by the contractor within quoted rates.

- 9. Co-ordination and followup action with electric supply agency shall be done by the contractor incase of failure/fault in supply/fluctuation in voltage.
- 10 The contractor shall immediately intimate the Engineer-in-charge about the major break down or failure of Electric supply.
- 11 Watch and ward shall be the responsibility of the contractor. Any loss due to theft or pilferage etc shall be borne by the contractor.
- 12 The payment to the contractor shall be made bi-monthly or at other suitable intervals desired by the contractor but not less than one calender month.
- 13 Proper handing/taking over of all the E&M installation shall be carried out by JE (E) incharge of the work and the contractor in writting immediately after award of work / before start of work.
- 14 The Engineer-in-charge if so desire may extend the contract upto 2 months or terminate the contract at any time giving 15 days notice.
- 15 If any staff employed by the contractor is found absent on a partiular time and date an amount proportionate to per shift shall be recovered from the contractor's bill.

16. All allied accessories/installations shall be kept in working order and incase any damages/loss are done to the pumping installations due to the negligence of the operational staff deployed by the contractor the contractor shall have to make good the damage/loss at his own cost. Incase the contractor fails to rectify the damage/loss within reasonable time, the same shall be got rectified/replaced by the department at the risk and cost of the contractor.
- 17 The contractor shall keep all the necessary spares and T&P at site required for operation and maintenance to be carried out under his contract.
- 18 In case of any disobedience or misbehavior by the operational staff of the contractor the Engineer-in-charge may ask the contractor dispense with the services of such staff with immediate effect. The contractor shall provide suitable substitute simultaneously.
- 19 The rates quoted by the contractor shall be inclusive of all taxes, duties and Govt. levies etc.
- 20 Pumping installation shall be painted(excluding panel board) once during the contract period.
- 21 Any Injury to the operational staff incase of any mishap during duty hours will be the liability of contractor.
