Item rate tender are invited for the work by Executive Engineer(E), Electrical Division No. 12, Central Nursery, Sector-5, Dwarka upto 3:00 PM on _____ on behalf of DDA from the approved contractors & eligible contract of DDA & CPWD and those of appropriate list of P&T, MES and Railways which shall be opened on the same day at 3:30 PM, Ground Floor, Vikas Minar, DDA Office, I.P. Estate, New Delhi in the presence of intending purchaser or their authorized representative.

The enlistment of the contractors should be valid on the last date of sale of tenders.


In case only the last date of sale of tenders is extended, the enlistment of contractor should be valid on the original date of sale of tenders.

In case both the last date of receipt of application and sale of tender are extended, the estimate of contractor should be valid on either on the two day i.e. original date of sale of tender or on the extended date of sale of tenders.

1. The annual financial turnover (gross) in Elect. Construction works in one of the preceding three financial years shall not be less than 100% of the estimated (gross) value of the work (duly audited by chartered accountant) on annualized basis (depending upon the time allowed for completion i.e. total estimated value divided by time of completion).
2. The satisfactory completion of at least two works of similar nature / class, Each costing not less than 50% of the estimated cost(gross) of the proposed work in the Central / State Govt. / Public Sector Undertaking / Govt. Autonomous bodies during the last five years.
3. The tender documents can be obtained on any working day from the office of Executive Engineer (E) / Electrical Division No. 12 DDA between 11:00 AM to 3:00 PM on payment of cost of tender (non-refundable) as well as amount of Earnest money mentioned against each work on production of valid enlistment registration certificate and valid registration with works contract Sales Tax dept. of GNCTD and Tax clearance certificate issued by the works contract cell in form XL sale of tender forms will be stopped four days (including the date of opening) before the date fixed for the opening of tender documents.
4. The manner of submission of tender, opening of the same and entry of contractors / their authorized representative at the place of opening shall be as provided in Clause - 3(a), (b) & (c) of PWD-6 forming part of the tenders documents.
