Sealed tenders are invited by the undersigned on behalf of DDA (Sports Wing) for the following works. The tender shall be in two parts viz. Part-I containing "Technical Bid" and Part-II comprising "Financial Bid". The two bids shall be submitted in **two separate sealed envelopes** clearly superscribing thereon Part-I "(Technical Bid)" and Part-II "(Financial Bid)", "Name of Work" and "Name of Agency / Firm" (from Delhi only). Only those agencies having two years experience of running swimming pools (respective field) in the last five years with annual turn-over of minimum Rs. 10 lacs for the last three years for each year duly certified by a Chartered Accountant will be eligible to tender. The bid not submitted in accordance with the prescribed manner will not be accounted for at all.

- i) Running, Maintenance and operation of Deck Area Services and Filtration Plant & DG Set of DDA swimming pools at Saket, Hari Nagar, Rohini, Paschim Vihar, Netaji Subhash (Jossola), Dwarka, Chilla, Vasant Kunj, Major Dhyan Chand (Ashok Vihar), Poorvi Delhi and Rashtriya Swabhimani Khel Parisar (Pitampura) Sports Complex (within complex premises).
- ii) Running, Maintenance and operation of Deck Area Services and Filtration Plant & DG Set, **(one job complete) on monthly licence fee basis**, of DDA swimming pools in green areas at Baba Gang Nath Sports Complex (Munirka), Pratap Nagar (Hari Nagar) and Kanti Nagar (Poorvi Delhi Khel Parisar).
- iii) Period of Contract : 01.04.2010 to 30.09.2010 or the actual date of handing over of pool site whichever is later to 30.09.2010.

Tender documents containing detailed terms and conditions may be obtained on payment of **Rs. 520/- (non-refundable)** in cash on production of authentic proof of the authorized representative of the firm/agency from the Cashier of the respective sports complexes upto **31.12.2009** on any working day from **11.00 AM to 4.00 PM**, which shall be received at Siri Fort Sports Complex, August Kranti Marg, New Delhi on **05.01.2010** upto **3.00 PM**. The earnest money of **Rs. 15,000/-** in the form of Pay Order/Demand Draft of any schedule bank approved by Reserve Bank of India drawn in favour of concerned Sports Complex to be submitted with the **Technical Bid**.
