Sealed tenders are invited for the following works from the approved and eligible contractors of DDA, CPWD, MES, P&T, Railways upto **3.00 PM** which shall be opened on the same day at **3.30 PM** at Vikas Sadan, DDA Office, New Delhi on the indicated dates.

Tender documents can be obtained on any working day from Sale Counter Press Building, Vikas Sadan, between **11.00AM to 3.00PM** on payment of cost of tender (non-refundable) mentioned against each work on production of valid enlistment certificate and valid registration with works contract cell of VAT Deptt. of GNCTD under Delhi Value Added Tax Act 2004 and tax clearance certificate issued by the works contract cell. The earnest money should accompany the tender in the form of call deposit receipt/demand draft of a scheduled bank guaranteed by RBI in favour of Sr. A.O. (CAU) Rohini, DDA. The earnest money may also be deposited in the form of FDR Valid for at least six months after the last date fixed for receipt of tender which should be pledged in favour of Executive Engineer concerned. The amount should be quoted in figures as well as in words. The item-wise and total tendered amount should also be worked out. Tender documents consisting of plan, specifications, the schedule of quantities and the set of terms and conditions of contract can be seen in the office of the respective EE between hours of **11.00AM to 3.00PM**.

The enlistment of the contractors should be valid on the last date of sale of tenders.

SPL. CONDITION FOR WORK at SL. NO.1

(a) The firms/contractor who have satisfactory completed similar nature of works costing as below during the last seven years ending 31.03.09 Must produce definite proof from the appropriate authority.

(i) Three similar complete works each of cost not less than the amount equal to 40% of the estimated cost put to tender,

OR

(ii) Two similar completed works each of cost not less than the amount equal to 50% of the estimated cost put to tender.

OR

(iii) One similar completed work costing not less than the amount equal to 80% of the estimated cost put to tender.

(b) The firm/contractor should have his own manufacturing unit.

(c) The tender will be issued by Sr. A.O./CAU (Rohini) after verification of documents by the EE/RPD-12.
