- **1.**The work comprises of running and operation of pump set, DG set and general lighting as per the inventory attached.
 - 2. The contractor shall depute the following staff under the contract:-
 - a)OperatorGd.II—4nos.(from 6AM to 2PM& 2PM to10PM) for operation of Submersible pump set &D G set.(2nos. for each pump house)
 - b)Khalasi-2Nos. one no. for each pump house (From 10PM to6AM)
 - c)Wireman Gd. I 1no. shall attend the site of work between 9AM to 5PM at least once in a fortnight on each pump house and as and when required.
 - 3. The contractor shall employ trained and competent staff to the satisfaction of Engineer-in-charge having two years experience on operation of pumps/DG set.
 - 4. The contractor shall supply the list of staff along with experience certificates to be engaged on the installation within seven days of award of work. Engineer in charge shall have the right to reject any staff employed by the contractor.
 - 5. The staff employed by the contractor shall wear proper uniform and wear badges displaying their name and designation. The staff shall also be given photo identity cards by the contractor displaying their name, father's name, address, date of birth, name of agency with address and telephone no. site for which employed and period of validity. A copy of the identity cards shall be given to the Engineer in charge within fifteen days of award of work.
 - **6.**The contractor shall employ staff throughout the period of contract including Saturdays, Sundays, Gazetted Holidays and National Holidays.
 - 7. Following records are to be kept at site of work:
 - a) Printed Log Book for recording operation.
 - b) Attendance register for staff deployed.
 - c)Complaint/Inspection register.

NOTE:- The contractor shall get the registers authenticated from Engineer in charge before use at site.

- 8. The following minor maintenance including preventive maintenance shall be carried out by the contractor. The details of work carried out shall be recorded in the log Book:-
- a)Servicing and greasing of pump/motors once in three months.
- b)Replacement of rubber packing of valves and worn out nuts and bolts etc.
- c)Replacement of gland dori as and when required.
- d)Replacement of HRC fuses as and when required.
- e)Replacement of Fl. Tubes, incandencent lamps and starters.
- f)Adjustment, alignment, tightening of nuts and bolts as and when required.

g)Replacement of worn out thimbles, wires, terminals etc.

h)To pup of battery water.

i)Daily cleaning of equipment/pump house.

NOTE:-The material required for carrying out above jobs shall be supplied by the contractor within the quoted rates.

- 9. The DG set shall be operated in case of electricity failure or as and when required by the engineer in charge . however P.O.L shall be supplied by the department.
- 10. Coordination and follow up action with the electric supply agency shall be done by the contractor in case of failure/fault in supply/fluctuation in voltage.
- 11. The contractor shall intimate the Engineer-in charge about the major break down or failure of electric supply in time.
- 12. Watch and ward shall be the responsibility of the contractor. Any loss due to theft or pilferage etc. shall be born by the contractor.
- 13. The payment to the contractor shall be made bimonthly or at other suitable interval desired by the contractor but not less than one calendar month.
- 14.Properhanding/taking over of all the E&M installations shall be carried out by the JE(E)in charge of the work to the contractor immediately after award of work/before start of work.
- 15. The Engineer in charge , if so desire may extend the contract up to two months or terminate the contract at any time giving 15 days notice.
- 16. If any staff employed by the contractor is found absent on a particular time and date an amount proportionate to per shift shall be recovered from the contractor's bill
- 17.All allied accessories /installations shall be kept in working order and in case any damages/loss is done to the pumping installations due to the negligence of the operational staff deployed by the contractor, the contractor shall have to make good the damages/loss at his own cost. In case the contractor fails to rectify the damages/loss within reasonable time ,the same shall be got rectified/replaced by the department at the risk and cost of the contractor.
- 18. The contractor shall keep all the necessary spares and T&P at site required for operation and maintenance to be carried under this contract.
- 19.In case of any disobedience or mis behavour by the operational staff of the contractor, the Engineer in charge may ask the contractor to dispense with the service of such staff with immediate effect. The contractor shall provide suitable substitute simultaneously.
- 20. The rates quoted by the contractor shall be inclusive of all taxes, duties and Govt. levies
- 21. Pumping installation shall be painted (excluding control panel) once during the contract period.

22. Any injury to the operational staff in case of any mishapes during duty hours will be the liability of contractor.
