Sealed Item rate tenders are **invited** for the following work by Executive Engineer, South Western Division No. 6, DDA on behalf of DDA upto 3.00 P.M. from the approved contractors & eligible contractors of DDA only which shall be opened on the same day at 3.30 P.M. at Ground Floor, Vikas Minar, DDA Office, I.P. Estate, New Delhi in the presence of intending purchaser or their authorized representative.

The tender documents can be obtained on any working day from the CAU Dwarka Zone/Sale Counter Vikas Minar between 11.00 A.M. to 3.00 P.M. on payment of cost of tender (non-refundable) on production of valid enlistment Certificate. Sale of tender forms will be stopped four days (including the date of opening) before the date fixed for the opening of tenders documents.

The manner of submission of tender, opening of the same and entry of the contractors or their authorized representative to the place of opening shall be as provided in clause 3(a),(b) and (c) of PWD-6 forming part of the tender documents.

The tender shall be accompanied with earnest money in cash (upto Rs. 10,000/-) only/Receipt, Treasury Challan/Deposit at Call Receipt of a Scheduled Bank/Fixed Deposit Receipt of a Scheduled Bank/Demand Draft of a Scheduled Bank issued in favour of Sr. A.O. (CAU) DWK Zone, DDA. **50% of the Earnest Money or Rs. 20 (Twenty) Lacs, whichever is less, shall be in the form prescribed above and balance can be accepted in the form of Bank Guarantee issued by a scheduled bank.**

It shall be ensured that Demand Draft/Fixed Deposit Receipt is valid for a period of Six Months or more after the last date of receipt of tender and the same shall be in favour of Sr. Accounts Officer, CAU (DWK) . No interest shall be paid on Earnest Money as deposited with DDA.
