The tender documents can be had on any working day from the tender sale counter at DDA Press Building, Vikas Sadan, near INA Market, New Delhi between 11.00 A.M. to 3.00 P.M. on payment of cost of tender (Non-refundable) mentioned against each work on production of valid enlistment registration certificate and valid registration with Works Contracts Cell of Sales Tax Department of GNCTD and Tax Clearance Certificate issued by the Works Contracts Cell in `Form - XI'. Sale of Tender Form will be stopped 4 days (including the date of opening) before the date fixed for the opening of tender documents.

The earnest money should be paid in the form of call deposit receipt / demand draft of a Scheduled Bank guaranteed by Reserve Bank of India in favour of "Sr. Account Officer, CAU (Rohini) DDA". The earnest money may also be deposited in the form of F.D.R., which should be pledged in favour of "EE/RPD-12, Rohini, DDA" and should be valid for at least six months after the last date fixed for receipt of tender.

(a) The firms/Contractor who have satisfactory completed similar nature of work costing as below during the last five years ending 31.03.2010. Must produce definite proof from the appropriate authority.

(i) Three similar complete works each of cost not less than the amount equal to 40% of the estimated cost put to tender.

OR

(ii) Two similar completed works each of cost not less than the amount equal to 50% of the estimated cost put to tender.

OR

- (iii) One similar completed work costing not less than the amount equal to 80% of the estimated cost put to tender.
- (b) Tender documents for non DDA & CPWD contractors shall be issued by CAU(R) after verification of documents by EE/RPD-12.

The tenderers are advised to inspect the file, drawing and N.I.T. before tendering. The rates should be quoted in figures as well as words. The item-wise and total tendered amount should also be worked out.

The tenderer, whose tender is decided to be accepted by the Competent Authority, shall be required to submit Performance Guarantee equal to 5% of the tendered amount in the prescribed form in accordance with Clause 1-A of the conditions of contract mentioned in N.I.T., within 07 (Seven) days from the date of issue of letter of intent, failing which the earnest money deposited by him / them shall be forfeited absolutely.

#### Conditions:-

- 1. The work shall be carried out as per CPWD Specification/DJB Norms.
- 2. The water shall also be supplied by the agency as & when required on one hour telephonic message.
- 3. The agency shall submit mobile No to Engineer-in-Charge and shall be available on phone 24x7 hours.
- 4. Penalty of Rs.3000/- (Rs. Three thousand only) per trip will be imposed to the agency if the agency fails to supply the water as per requirement /direction of Engineer-in-Charge.
- 5. A board shall be displayed in front of tanker displaying on DDA Duty.
- 6. The No. of tankers to be supplied can vary on each day from minimum of Nil to more 15 tankers/day as per daily requirement. No claim shall be entertained in this regard. Proper record be maintained for supply of tankers showing tanker No. i.e all details including time of receipt etc.
- 7. A receipt of the tanker daily signed by the DDA Staff shall be submitted to the department by the agency, otherwise no payment will be made.
- 8. Royalty payment shall be deposited in DJB Office through official letters and its deposit receipt in original issued by the DJB to the agency shall be submitted to the department before payment.
- 9. The agency shall be solely responsible for any mishappening accident, while transportation of water.
- 10. The tankers to be used for water supply shall be hygienic.
