- 1. Item No. 1 will be done daily complete in all respect failing which penalty of Rs. 3500/- per day will be imposed without any notice. (Minimum 11 Nos. of Safai Karamchari are required daily).
- 2. Item No.2 will be done on alternative days (30 days) failing which a penalty of Rs. 2000/- per day will be imposed without any notice (minimum 5.75 nos.) of Safai Karamchari are required on alternate days).
- 3. Item No. 3 will be done once a week failing which a penalty of Rs. 1000/- per day will be imposed without any notice (minimum 4 (four) Nos. of Safai Karamchari are required once a week).
- 4. Item no. 4 if the agency fail to remove the refuse on any day penalty of Rs.2000/- per trip will be imposed for the work not carried out. Challan will be submitted to the deptt. as a proof for disposing the refuse to the approved MCD dumping ground. Dumping ground charges will be deposited by the agency and no extra payment shall be made to the contractor.
- 5. In case of failure by the agency to execute the work as per satisfaction of Engineer-in-charge. The work will be carried out at his risk and cost and amount will be recovered from the contractor.
- 6. No extra payment shall be made agency for the work done on Saturday, Sunday & Holiday.
- 7. The agreement will be closed as and when the services are transferred to M.C.D.
