



PRESS TENDER NOTICE

- 1.1 Sealed Item rate tenders are invited from the specialized agencies, who are also registered in the appropriate class with the DDA, CPWD, MES, P&T, MCD and NDMC, for the following work by Executive Engineer/WD-10, Central Nursery, Sector-5, Dwarka, New Delhi on behalf of DDA up to 3.00 PM on _____ who have satisfactory completed at least two works of similar nature/class, each costing not less than 50% of the estimated cost (gross) of the proposed work during the last five years. The Annual Financial turnover (gross) in civil work in one of the preceding three financial years shall not be less than 100% of the estimated (gross) value of the work (dully audited by chartered accountant) on annualized basis (depending upon the time allowed for completion i.e. total estimated value divided by the time of completion), which shall be opened on the same day at 3.30 PM. at Ground Floor, Vikas Minar, DDA Office I.P. Estate, New Delhi in the presence of intending purchaser or their authorized representative.

NOTE:- Similar nature of works means, the construction of underground watertank, watergalleries, bridges and aquaducts, sewerage pumping station, sewerage treatment plant, water treatment plant and command tank & sump wells.

- 1.2 The enlistment of the contractors should be valid on the last date of sale of tenders. In case only the last date of sale of tender is extended, the enlistment of contractors should be valid on the original date of sale of tenders. In case both the last date of receipt of application and sale of tenders are extended, the enlistment of contractor should be valid on either of the two date i.e. original date of sale of tender or on the extended date of sale of tenders.
- 1.3 The tender documents can be obtained on any working day from the office of the Executive Engineer/WD-10 between 11.00 A.M. to 3.00 P.M. on payment of cost of tender (non-refundable) on production of valid enlistment Certificate. Sale of tender forms will be stopped four days (including the date of opening) before the date fixed for the opening of tender documents.
- 1.4 The manner of submission of tender, opening of the same and entry of contractor or their authorized representative to the place of opening shall be as provided in clause 3(a), (b) and (c) of PWD-6 forming part of the tender documents.
- 1.5 The tender shall be accompanied with earnest money in cash (up to Rs.10,000/-) only /Receipt, Treasury Challan/Deposit at Call Receipt of a Scheduled Bank/Fixed Deposit Receipt of a Scheduled Bank/Demand Draft of a Scheduled Bank issued in favour of Sr. AO(CAU) Dwarka DDA. 50% of the Earnest Money or Rs.20(Twenty)Lacs, whichever is less, shall be in the form prescribed above and balance can be accepted in the form of Bank Guarantee issued by a scheduled bank.
- 1.6 It shall be ensured that Demand Draft/Fixed Deposit Receipt is valid for a period of Six months or more after the last date of receipt of tender and the same shall be in favour of Sr. Accounts officer(CAU)Dwarka). No interest shall be paid on Earnest Money as deposited with DDA.
