ELIGIBILITY CRITERIA :-

(b) For works costing above Rs. 25.00 lacs upto 2.00 crores, (Sl. No. 2) tenders shall be issued to DDA & CPWD enlisted contractors as per their enlistment. The tenders shall also be issued to non-DDA, non-CPWD contractors provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost in the last five years ending last day of the month previous to the one in which the tenders are invited. The tender documents shall be sold by CAU (EZ) / Tender Sale counter Vikas Minar after verification of eligibility criteria by the Executive Engineer, ED-5.
