Sealed item rate tenders for the following works are invited from the firms/contractors of repute on Two Bids System by Executive Engineers on behalf of DDA:

The earnest money in the form of Receipt Treasury Challan/ Deposit at call receipt of a scheduled Bank/ Fixed Deposit Receipt of a Scheduled Bank/ Demand Draft of a Scheduled Bank issued in favour of Sr. A.O./ CAU/North Zone, DDA shall be deposited at the time of submission of tender documents. Since the amount of earnest money is more than **Rs. 5.00 Lacs**, maximum 50% of the total earnest money is acceptable in the form of Bank Guarantee also. So in this case minimum 50% of the earnest money shall be deposited in the shape prescribed above. For balance amount earnest money, Bank Guarantee in favour of Sr. A.O./ CAU/North Zone/DDA will also be acceptable.

Contractors/firms who fulfill the following requirements shall be eligible for qualification for the work:

- Experience of having successfully completed works during the last 7 years ending last day of the month previous to the one in which applications are invited. Three similar completed works (at least one of them should be for a Central Government/ Central Autonomous Bodies/ Central Public Sector Undertaking) costing not less than an amount equal to 40% of estimated cost put to tender.  
OR  
Two similar completed works, costing not less than an amount equal to 50% of the estimated cost put to tender.  
OR  
One similar completed work of aggregate cost not less than an amount equal to 80% of the estimated cost put to tender.
- Should have had average annual financial turnover of 30% of contract value for construction works during the last three years ending 31st March, 2006.
- Should not have incurred any loss in more than two years during the last five years ending 31st March, 2006.
- Should have solvency for an amount equal to 40% of the estimated cost of the work certified by their bankers issued on or after 01.04.2006.

The agency has to furnish certificate to the effect that upto date returns under Delhi VAT on Works Contract Act, 2004 have been filed along with the copy of such returns. Tenders are invited in three separate sealed envelopes marked "Earnest Money", "Technical Bid" & "Financial Bid" (Tender Form PWD8). All the three envelopes shall be submitted together in another sealed envelope. Earnest money enveloped shall be opened first. Technical Bid envelope of those contractors shall be opened whose earnest money is found in order. Financial Bid of qualified contractors only shall be opened within 30 days from the date of receipt of tenders at notified time, date and place in presence of qualified contractor or their representatives who wish to be present. The validity of tenders shall be ninety days from the date of opening of financial bid.

Desirous firms/ contractors may obtain Tender and Technical Bid Document on request in writing from the Executive Engineer, Northern Division-8 & 12 respectively between **10:00 AM to 3:00 PM** on payment of **Rs. 2,500/-** (Rs. Two Thousand Five Hundred only) in cash (non-refundable) to Sr. A.O./CAU/North Zone/DDA, Ashok Vihar, New Delhi, as per programme given as under:
