Both the envelopes shall be placed in another envelope with due mention of Name of work, date & time of opening of tenders and to be submitted in the office of Executive Engineer during the period mentioned above.

Online tender documents submitted by intending bidders shall be opened only of those bidders, whose Earnest Money Deposit, Cost of Tender Document and e-Tender Processing Fee and other documents placed in the envelope are found in order.

Criteria of eligibility for submission of tender documents.

(A) For works costing upto Rs. 40 lacs in case of B&R/Civil, tender shall be issued to contractors registered with DDA only.

(B) For works costing up to Rs. 40 lacs in case of B/R Civil tenders shall be issued to contractors regd. With DDA and CPWD B & R PWD, MES & Others Regd. With state Govt. Department for the work of boring of Bore well.

Earnest Money and cost of tender shall be deposited through RTGS/NEFT in the account of Sr. A.O. of the concerned CAU having account no. 1290300366 with Central Bank of India, bank and Manglapuri, New Delhi branch (IFSC code CBINO283498). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date 20.03.13. The Executive Engineer concerned will get tender cost/earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tenders are opened. A part of earnest money is acceptable in the form of bank guarantee also. Earnest Money up to Rs. 20.00 lacs will have to be deposited through RTGS/NEFT mode. If the amount of E.M. is more than Rs. 20.00 lacs then the amount of E.M. beyond Rs. 20.00 lacs can be deposited in the form of Bank Guarantee also such bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission. Earnest money and cost of tender have to be deposited through separate transactions.
