Criteria of eligibility for submission of tender documents.

1. Tender shall be issued to contractors registered with DDA only.

Earnest money and cost of tender shall be deposited through RTGS/NEFT in the account of Sr. A.O. (CAU)Dwarka/DDA having account no. 1290300366 with Central Bank of India, and Manglapuri brnach(IFSC code 283498) The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer concerned will get tender cost/earnest money verified from CAU based on the unique transaction reference numner against each RTGS/NEFT payment before the tenders are opened.
