Sub.: Partial modification in the LOP of Bindapur, Pkt. 4 in Zone K-II (Dwarka) for accommodating UGR plot. (No: F1(49)12/Plg./Dwk./Pt. I)

Synopsis:

The request for providing UGR plot in Bindapur, Pkt.4 was discussed in the meeting Chaired by V.C., DDA on 3.7.12. Accordingly, a plain table survey was conducted for Vacant land around cremation ground in the LOP for availability of the plot.

Background:

A meeting was held in the Conference Hall of Vice-Chairman, DDA on 3.7.12 to discuss the issue raised by Sh. Mukesh Sharma, Hon'ble MLA. It was decided vide item No.1 that layout plan of Pkt.4, Bindapur be modified partially for accommodating UGR plot in vacant land around cremation ground plot in the LOP.

Examination: 2.0

- a) As per the decision taken in the meeting, the plain table survey was conducted and placed at Annexure-I. Accordingly, about 1600 sq.m. area is available in irregular shape around existing cremation ground plot. The landscape plan for this area was prepared by the Landscape Department.
- b) As per MPD-2021, a plot measuring 2000 sq.m. is required for Underground Water Tank and Public Utilities are permitted in all use zones:

As far as planning is concerned UGR measuring 2000 sq.m. is required can be located in this Vacant land surrounding the existing cremation ground. Since, the layout plan was prepared by the Landscape Department, the exact location and the dimensions to be incorporated in their layout plan by the Landscape Department in consultation with Chief Engineer (Dwarka). 
