#### **SYNOPSIS**

As per layout plan of PSP Pocket-14, Sector-8, a plot measuring approx. 0.91 hact in irregular shape is available due to the cancellation of earlier allotment as per the details available in IL File No.F.25(02)09/IL. The same plot is to be considered for allotment to the Police Department for Police Station. Therefore, a partial modification in the LOP is required to utilise this plot for police station.

#### 1.0 Background:

The Institutional Land Branch has forwarded the request of Police Department vide file No. F.25(02)09/IL to establish a police station for Palam area. As decided in the meting of Principal Commissioner (LM, Personnel & Systems), DDA held on 1/10/12, a joint site inspection was carried out on 3/10/12. The Dy. Commissioner of Police (L&B), Police Headquarter, Delhi vide letter No. 9262/L&B Cell/ PHQ (DA-III) dt. 9/10/12 has intimated Dwarka Planning Office that the land under reference is found suitable for construction of Police Station for Palam Village & requested to allot this land to Delhi Police & copy of the letter is Annexed as Annexure-II.

#### 2.0 Examination:

The layout plan of PSP Pocket-14, Sector-8, Dwarka is already approved by VC, DDA in 1996 in file No. F.4(8)93/Dwk./Pt.-I, a copy of the approved LOP is enclosed as Annexure-I. In this LOP, there is an irregular shape plot which was earlier allotted to some Institute and subsequently allotment canceled by the IL Department. Therefore, this plot is available for the consideration of allotment as a Police Station.

As per MPD-2021 Table 13.10 Planning Norms & Standards for Security (Police facilities) area of 1.0 hact. is required for police station, whereas available area is marginally less i.e. 0.91 hact. Since, this is heavily built up area and no other site is available, the area of 0.91 hact. as per LOP may please be considered for Police Station.

### 3.0 Proposal:

As stated above, the plot measuring 0.91 hact designated as PSP in LOP of Pocket-14, Sector-8, is proposed to be utilized for Police Station. The copy of the approved LOP showing the plot under reference is enclosed as Annexure-I.

- iii) After feasibility report from Chief Engineer (Dwarka), the LOP to be referred to LD Wing for verification of allotment status & obtaining approval of the Competent Authority before allotment/ disposal as per Policy.




