In case only the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders. Those contractors not registered on the website mentioned above, are required to get registered beforehand. The intending bidder must have valid class-II digital signature to submit the bid.

Earnest money and cost of tender shall be deposited through RTGS/NEFT in the account of **CAU(MPR)** Account No. **13940110014875** Bank **UCO Bank, shapurjat** New Delhi. IFSC Code **UCBA0001394**. The unique transaction reference of RTGS/NEFT shall have to be Uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer, **Sports Division-1** will get tender cost earnest money verified from **CAU(MPR)** based on the unique transaction reference number against each RTGS/NEFT payment before the tender are opened.

A part of earnest money is acceptable in the form of Bank Guarantee also Earnest Money upto 20.00 lacs will have to be deposited through RTGS/NEFT mode, if the amount of E.M. is more than Rs.20.00 lacs then the amount of E.M. beyond Rs.20.00 lacs can be deposited in the form of Bank Guarantee also such bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission.
