You are hereby granted permission to hold religious/social/marriage function on account of Use of DDA's land at M. Gable Street, Motinagar, measuring 2000 sq. mts. on 27/11/11 to 29/11/11 for temporary use as per above terms & conditions is already accepted by you.

1. The said booking for temporary use permitted above shall not be misused for any other purpose. If any violation is found at site, the land shall be vacated with force without any notice and DDA shall not be responsible for any damage or loss on vacating. In such eventuality, your security deposit shall stand forfeit.
2. The said land shall also be used only for the purpose of use permitted above. In case such circumstances arise, you shall not be responsible for any damages or losses in your movable property. Your security deposit shall also be forfeited under such circumstances.
3. The party booking is not allowed to be found by the field staff of DDA that temporary booking has been obtained by you misrepresenting the facts, and in practicing any fraudulent or illegal operation, the permission so granted shall automatically stand cancelled and you will be liable for conviction finally, besides criminal proceedings and forfeiture of your security deposit. DDA shall not be liable for any damages or losses sustained by you or any such finally evicted.
4. It must be noted that the DDA's permission for temporary use shall not cover any damage or loss to the building wall, grill fencing, gates, etc. or any other structure or any damage in this regard and you shall be liable for any such value damage.

Banking within the MDA's circuit level is allowed. No refund shall be allowed if the cancellation is within the 15 days. Banker's requests and these orders shall be applicable with prospective effect. Banking as permitted above is non-transferable. In case of unauthorized transfer of banking is detected by field staff of MDA, both the parties i.e. transferor and transferee shall be liable for penal actions besides suspension and forfeiture of security deposit. MDA reserves the right to cancel the said permission without any notice in case of violation of the said terms and conditions. MDA also reserves the right to withdraw permission under forced circumstances without any liability or claim of damages and losses from your side.
