Please refer to your application dated 17.8.11 regarding booking of vacant land for temporary use to hold religious/social marriage. You are hereby granted permission to hold religious/social/marriage function in account of USE H Blk WKO puri measuring 2000 sq. mts. on 3/12/11 to 5/12/11 for temporary use on the following terms & conditions as already accepted by you.

1. The said booking for temporary use permitted above shall not be misused for any other purpose. If any misuse is found at site, the land shall be vacated with force without any notice or intimation and DDA shall not be responsible for any damage or loss in this regard. In such eventuality, your security deposit shall stand forfeited.
2. The said land shall also be vacated if any other more land is booked then permitted above or more than the permitted days as above. Under such circumstances, DDA shall not be responsible for any damages or losses to your movable properties. Your security deposit shall also be forfeited under such circumstances.
3. The party booking is not allowed to be evicted if found by the filed staff of DDA that temporary booking has been obtained by you misrepresenting the facts, and in practicing any fraud or by using impersonation, the permission so granted shall automatically stand cancelled and you will be liable for eviction forcibly, besides criminal proceedings and forfeiture of your security deposit, DDA shall not be liable for any damage and in losses sustainable to you during such forcible eviction.
4. It must that on DDA's property such as boundary wall, grill fencing, gates, roads & trees etc. is damaged, in case of any damage in this regard your security shall stand forfeited by you to the extent of the repair damage.

5. All bills to be issued by the bank shall be prepared by the Chief Cash Officer under the supervision of the Chief Cash Officer, and the Chief Cash Officer shall be responsible for the accuracy of the bills.
6. In packing and handling, the bank's own staff is allowed.
7. You will have to make your own arrangements for water, electricity etc.
8. You will have to make your own arrangements for transport and fuel etc. is subject to the various Acts laws in force and you will have to get permission where it is needed from the authority concerned.
9. In case of banking is cancelled due to any reason by you and the intimation of this cancellation is made before one month from the date of function you have to comply with 10% and 20% refund of intimation is made before 15 days of cancellation. No refund shall be allowed if the intimation is within the 15 days from the date of function. Such refund shall be allowed only on properly documented requests and these intakes shall be open only with prospective effect.
10. Banking as permitted above is non-transferable. In case of unauthorized transfer of banking is detected by field staff of BWA, both the parties i.e. unauthorized transfer and transferee shall be liable for penal actions besides cancellation and forfeiture of security deposit.
11. BWA reserves the right to cancel the same permission without any notice in case of violation of the said terms and conditions.
12. BWA also reserves the right to withdraw permission under forced circumstances without any liability in claim of damages and losses from your side.
