Release of amount beyond sanctioned A/A & E/S +10% amount in

anticipation of sanction of RPE.

The above said agenda presented and submitted by CE(HQ) with a proposal as under:

There are some projects in DDA where contract was awarded beyond A/A & E/S amount. In such ongoing projects where the agreement amount is more than A/A & E/S amount, it is seen that the

maximum permissible payment in the contract i.e. (A/A & E/S +10%) amount has already been exhausted. RPE for these projects have already been submitted are under process.

Since, the works are still in progress, hence, further payment will be required to be made to meet contractual obligation.

Since, all above projects have already been awarded & work is in progress, the payment for work done cannot be stopped, as it will not only hinder the progress of work but also lead to arbitration. In order to maintain the progress of work and to avoid litigation in future.

It is therefore, proposed to release up to 90% amount of contract in operation and covered in the RPE under process, as per physical progress of work, subject to availability of funds in the budget.

However, in all such projects, scrutiny of RPE should be expedited and sanction of competent authority may be obtained within two months.

In order to avoid such eventuality of award of work in excess of A/A & E/S amount, it has been decided in the 1st WAB meeting held on 31.1.2018 that the PE shall be got modified on the basis of lowest quoted justified rates and approval of the competent authority be obtained to the modified PE before award of work.

In this regard a circular is issued vide no EM1(10)Cir./Pt./432 dt 14.05.2017 attached as Annexure 1.

The matter was discussed in length & after due deliberations, it was decided:

(i) In all above cases, it is seen that contract was awarded beyond the A/A & E/S amount. After award of contract Revised Preliminary Estimate (RPE) was not initiated which shows laxity on part of concerned executing engineers. WAB expressed its displeasure over such laxity and instructed that in all such cases the responsibility shall be fixed for delay in initiating RPE. WAB also observed that in all the above works since the contract has been awarded & the works are in progress at an advanced stage, the payment for the works cannot be stopped as it will not only hinder the progress of work but also lead to arbitration and delay completion of works.

Being fait accompli WAB decided to release up to 90% amount of contract in operation and covered in the RPE under process except in respect of the work at Sl.No 3(iii), as per physical progress of work. However, scrutiny of RPE should be expedited and sanction of competent authority should be obtained within one month.

(ii) It has also come to notice of WAB that there are many cases where expenditure has exceeded the A/A & E/S amount +10% but RPE has still not been submitted to competent authority for approval.

WAB instructed that RPE of all such pending cases shall be initiated & submitted for approval within three weeks along with proper justification/reasons of exceeding the cost. All Zonal Chief Engineers shall put up the agenda of such RPE's for consideration of EAC in its next meeting.

Compliance of the above decisions should be put up for information of WAB.
