### 1. WAB Agenda Item No. 455/CE(R)

Name of Work: D/o 443.44 Hect. of land, Sector-34 & 35, Phase-

V, Rohini.

**S.H.:** C/o Foot Path and Drain of 45 M R/W road along

submitted The agenda by CE(Rohini) vide note FO/CE(R)11(617)2017-18/DDA/317 dated 28/02/2018 & presented by CE(R) with the recommendation for acceptance of award of the work to M/s ManMohan Singh Wadhwa Construction Pvt. Ltd. being the lowest bidder with quoted amount of Rs. 2,26,76,810/- i.e. 38.05% below the estimated cost. FM/DDA pointed out that there is a tendency to split the work into small value tenders. Also, it has been observed in many cases of arbitration that the tender is awarded at a very competitive rate (below estimated / justified rates) and during course of execution, huge variations are permitted at market rates benefiting the contractor. Engineering officers must guard against such practices. Also, it was suggested that CE(HQ) may study the practice followed in other central government organizations such as railways where quantity executed beyond a certain laid down percentage is paid at quoted rate minus 2 % or so. Similar conditions can perhaps be incorporated in DDA's tender documents. VC/DDA and EM/DDA are of the same opinion, and it was directed that the tender of a work be invited after thorough due diligence and without resorting to splitting.

After due discussion & deliberation, Board agreed in principle with recommendation of CE(RZ) and accept the tender of M/s ManMohan Singh Wadwa Construction Pvt. Ltd. after fulfilling all codal formalities at his quoted rate, i.e. 38.05% below the estimated cost. Board also instructed competent authority should ensure that in case of any necessity of deviation in the contract there should not be any vitiation, and L1(Lowest bidder) should remain always lowest. In case of deviation beyond permissible limit rate will be limited to agreement rate only. However, in case of extra/substituted items the applicable rates will be prevailing market rate minus percentage quoted rate of the agency to ensure that no undue benefit occurs to agency.

Accordingly, CE(Rohini) shall conduct negotiation with L-1 (lowest bidder) prior to award of the work and obtain an undertaking as above from the agency.
