## Minutes of the Meeting

A review meeting on the issues raised by Sh. Vijender Gupta, MLA was held on 13.09.2017 at 04.00 PM in E.M.'s chamber, Vikas Sadan, under the chairmanship of E.M./DDA. The list of the officers who attended the meeting is enclosed as Annexure 'A'. The following issues were reviewed and decisions were taken as under:

Development of Parks with public conveniences in sports field/ large parks of Rohini and their maintenance.

Sh. Rajender Kumar, EE/ND-5 intimated that PG for new toilets at 7 locations has been sent for verification. L.O.I has been issued. All tenders will be awarded by 20.09.2017.

(2) Construction of Community Hall in Sec-8 Rohini.

Community Hall at Sector-8, Rohini: Sh. V.K. Saluja intimated that the matter is subjudice in High Court Delhi. Next date of hearing is 18.09.2017.

(3) Construction of Socio Cultural Center at Rohini.

Sh. Chaman Lal Addl. CA/DDA intimated that agenda has been submitted in DUAC as well as for Screening Committee Meeting. Hon'ble MLA was requested to pursue the matter with DUAC for early resolution. Representatives from consultant intimated that bid document is ready. Hon'ble MLA desired that area of Socio Culture Centre may be allowed to use for general public at nominal fees for better acceptance.

(4) Developing Green Belt from Rohini Court Sec-14 to DeepaliChowk Sec-3 along outer Ring Road by erecting boundary wall & wire fencing & plantation.

Sh. Ishwar Chandel, EE/RPD-2 intimated that work for raising the height of boundary wall with grill is in progress and whole work will be completed by 20.09.2017.

(5) Providing flats/land etc. to J.J. dwellers of Suraj park J.J. Clusters situated in H&F Block of Sector 18 Rohini as per DDA policy of Rehabilitation.

Sh. Chaman Lal Addl. CA/DDA intimated that agenda has been sent for Screening Committee Meeting.
