### Minutes of the Meeting

A review meeting on the issues raised by Sh. Vijender Gupta, MLA was held on 07.06.2017 at 04.30 P M in E.M.'s chamber, VikasSadan, under the chairmanship of E.M./DDA. The list of the officers who attended the meeting is enclosed as **Annexure 'A'**. The following issues were reviewed and decisions were taken as under: -

## (1) <u>Issue No.1 – Cleaning of vacant plots/ Removal of Jungle Grass and Garbage & Providing boundary wall in Sec-7,8,9,13,14, Prashant Vihar, 15, 18, 19, Suraj Park etc. of Rohini Assembly.</u>

Sh. Sunil Kumar SE intimated that tender for removal of Malba from Vacant Plots already exist and Malba is being removed regularly. Hon'ble MLA produced a letter signed by residents of pocket A-3, Sector-7, Rohini, complaining about Malba at park in their area. (Copy enclosed) as **Annexure 'B'**

### (2) <u>Issue No.2- Development of Parks with public conveniences in sports field/ large parks of Rohini and their maintenance.</u>

Hon'ble MLA pointed out that most of the toilets in the park is not getting water supply. It was directed to make toilets functional at parks & to resolve this problem latest by 15.06.2017.

#### (3) Issue No.3 - Construction of Community Hall in Sec-7,8 & 13 Rohini.

<u>Community Hall at Sector-7, Rohini:-</u>Sh. Sunil Kumar, SE/CC-6 intimated that tree cutting permission has been received from forest deptt. and work has been started.

Community Hall at Sector-8, Rohini:-CE(R) informed that drawings has been received. Work will be start soon.

### (4) Construction of Socio Cultural Center at Rohini.

Sh. A K Verma SE/CC-14 informed that work has been awarded.

# (5) <u>Issue No. 5: Developing Green Belt from Rohini Court Sec-14 to DeepaliChowk Sec-3 along outer Ring Road by erecting boundary wall & wire fencing & plantation.</u>

Sh. Sunil Kumar, SE/CC-6 stated that old contract is in a process of rescinding the work as agency was not completing the work. In this context, joint inspection is to be carried out on 08-06-2017. Remaining work will be awarded to new agencies as early as possible.

### (6) <u>Issue No.6: Providing flats/land etc. to J.J. dwellers of Suraj park J.J. Clusters</u> situated in H&F Block of Sector 18 Rohini as per DDA policy of Rehabilitation.

It was informed that the site for housing scheme under reference is to be worked out on the line of Jailor Wala Bagh Scheme and Kalkaji Scheme after selection of the site by engineering wing to relocate the J. J. Clusters. LD wing is to give the allotment, status of Nursery school site at block H, sector-18, Rohini and also status of allotment of post office, night shelter and status of designing of CSC pockets by Architecture Wing. Same will be got examined on file.

### (7) Issue No.8: Development of Parking site, Sector-14, Rohini.

CE(R) informed that estimate for surface parking has been prepared . Paver block will be laid by end of next month .

### (8) Issue Regarding Vacant land at pocket -8A, Block H, Sector-15 Rohini.

The issue was raised by Hon'ble MLA..The allotment status is to be confirmed by Land Branch copy of layout plan will be sent by Rohini Planning office to PC (LD) Office for confirming the allotment status. Hon'ble MLA desired to get it examined regarding change the use of site as park. After the receipt of report from Lands Branch, the matter shall be examined.

### (9) Regarding Community Hall at Sector- 15 Rohini.

Hon'ble MLA desired to convert the site under reference as Multipurpose Community Hall for the resident of Sector-15. It was decided that the matter will be examined on file and shall be submitted for decision in the matter.
