Minutes of the Meeting

A review meeting on the issues raised by Sh. Vijender Gupta, MLA was held on 20.06.2017 at 04.00 PM in E.M.'s chamber, VikasSadan, under the chairmanship of E.M./DDA. The list of the officers who attended the meeting is enclosed as **Annexure 'A'**. The following issues were reviewed and decisions were taken as under: -

(1) <u>Issue No.1 – Cleaning of vacant plots/ Removal of Jungle Grass and Garbage & Providing boundary wall in Sec-7,8,9,13,14, Prashant Vihar, 15, 18, 19, Suraj Park etc. of Rohini Assembly.</u>

CE(RZ) submitted report on prescribed performa regarding cleaning/removal of garbage at vacant DDA plots in Rohini Zone. Hon'ble MLA desired that these vacant plots may be developed as park or free parking.

(2) <u>Issue No.2- Development of Parks with public conveniences in sports field/ large parks of Rohini and their maintenance.</u>

Sh. V.K. Saluja intimated that water has been provided in 3 toilets. Water in remaining toilets shall be provided by 27.06.2017.

(3) <u>Issue No.3 – Construction of Community Hall in Sec-8 Rohini.</u>

<u>Community Hall at Sector-8, Rohini</u>:- Shri V.K. Saluja intimated that layout of the committee hall has been completed and work will start in near future.

(4) Construction of Socio Cultural Center at Rohini.

It was directed that Sh. Hemant Verma, Sr. Architect will coordinate with consultant agency and develop a plan as per master plan provisions.

(5) <u>Issue No. 5: Developing Green Belt from Rohini Court Sec-14 to Deepali Chowk Sec-3 along outer Ring Road by erecting boundary wall & wire fencing & plantation.</u>

CE(RZ) informed that work has been started and will be completed by 30.06.2017.

(6) <u>Issue No.6: Providing flats/land etc. to J.J. dwellers of Suraj park J.J. Chasituated in H&F Block of Sector 18 Rohini as per DDA policy of Rehabilitation.</u>

CE(RZ) intimated that file has been sent to LM Branch for survey of the area. It was also intimated that Architect wing, DDA has to propose EWS housing project in the area. It was directed that the matter should be put up in file for in principle approval of the project from VC, DDA.

(7) <u>Issue No.8: Development of Parking site, Sector-14, Rohini.</u>

CE(R) intimated that tender of the work will be awarded 01.07.2017 and work will be completed by 31.07.2017.

(8) <u>Issue Regarding Vacant land at pocket -8A, Block H, Sector-15 Rohini.</u>

The issue was raised by Hon'ble MLA. Hon'ble MLA desired to get it examined regarding change the use of site as park. It was directed that the case may be taken up in the screening committee by Dir.(Planning).

(9) Regarding Community Hall at Sector- 18 Rohini.

Hon'ble MLA desired to convert the site under reference as Multipurpose Community Hall for the resident of Sector-18. It was decided that the matter may be put up in screening committee for decision. It was directed that Dir.(Planning) will put up concept paper for obtaining approval from V.C./DDA for processing it in Authority meeting.

(10) Community Hall at Sector-5, 6 & 11, Rohini.

Hon'ble MLA along with councilor of the area raised issue about non function of above said community halls. CE(RZ) intimated that clearance from Fire Deptt. is still pending due to which committee halls are nonfunctional. CE(RZ) also produced the letter which has been sent to fire department requesting for the clearance. A copy of the letter was also handed over to Hon'ble MLA to pursue the matter from fire department.

(11) <u>Development of Sector-23/33, Sports Complex.</u>

It was directed to Chief Engineer (Project) to develop the above said Sports Complex on priority basis.

(12) Development/maintenance of Sardar Patel Jheel at Pooth Kalan.

Hon'ble MLA along with councillor of the area raised issue about bad condition and non-maintenance of above said Jheel. Remedial action as per rules/law be taken.

(13) <u>Councillor Mrs. Kanika Sandeep Jain raised issues about following vacant lands/parks.</u>

- (a) Jhaliwala Park, Sector-5, Rohini is in bad condition. Malba removal and plantation is required.
- (b) DDA vacant land for post office, Sector-11, opposite Diksha School- is in bad condition/garbage dumping ground. Cleaning is required.
- (c) Green belt park on 24m road, opposite Pocket A-1 & A-3, Sector-11, Rohini. Open gym is required to be installed in the park. (letter enclosed as Annexure 'B')
- (d) Vacant DDA land near petrol pump, Sector-6, Rohini is in bad condition/ garbage dumping ground. It may be cleaned and developed as park/playfield.

It was directed to Sh. Arjun Pal Singh, Dy. Dir.(Hort.) to complete all parks with green plantation by 31.7.2017 if permissible as per rules. It was further directed that a target of developing 5 parks with green plantation be achieved before next meeting i.e. 10.7.2017.

During meeting it was also decided that all the electrical works in Horticulture branch of Rohini Zone will be approved by CE(Civil)RZ or his SE(Civil) depending upon their competency with copy to CE(Elect.) & SE(Elect.) to improve efficiency.

The meeting ended with the vote of thanks to the chair.

The next review meeting is fixed for <u>10-07-2017 at 03:00 PM</u> which will be held under the chairmanship of EM, DDA in his chamber.
