**Minutes of the Meeting (10<sup>th</sup>)**

A review meeting (10<sup>TH</sup>) on the issues raised by Sh. Vijender Gupta, MLA on 19.08.2016 was held on 23.11.2016 at 04.00 PM, under the chairmanship of EM/DDA in his chamber. The meeting was attended by all concerned HODs/representatives. The following issues were reviewed and decisions were taken as under:-

**1. Development of Parks with Public conveniences in Sports field/large Parks of Rohini.**

**A) Providing lights in Parks of entire Rohini.**

- Sh. Vijender Gupta, MLA confirms that lighting in 8 gyms is in working condition.
- Lighting in park of sector-8 Rohini, near Hanuman Mandir is to be provided.

{Action: SE (Elect. Cir.-II)}

**B) Providing Toilets in parks:-**

- CE(RZ) said that a combined tender for 10 to 12 toilets in parks are being invited.

**2. Allotment Land/ Construction of Community Centres in Sector 7,8,13, & 15.**

**A) Community Hall Sector- 13 & 8 Rohini :-**

**(i) (Community Hall Sector- 8, Rohini)**

CE(RZ) informed that :

Tender for Structural consultant shall be invited by 24.11.2016.

(ii) **(Community Hall Sector-13 Rohini)**

CE(RZ) informed that :-

- Tender for the structural consultant has already been awarded.
- CE(RZ) said that work of structural drawing would be completed in time bound manner (within 10 days). CE(RZ) will pursue the matter.

3. **Multipurpose Community Hall at LS/OCF plot in Pocket G-20 and G-21, sector-7, Rohini :-**

- It was decided that CE(RZ) shall sanction detailed estimate for all three community hall on the basis of already constructed community hall on similar pattern may be prepared. The B.O.Q may be taken from final bill as entered in MB of already constructed community hall.
- Increase in quantities beyond items existing in B.O.Q shall be dealt in a manner that no escalation is paid by DDA.
- Tenders will be invited by 10.12.2016.

{Action: CE(RZ)}

4. **Community Hall at Sector-18, Rohini.**

CE(RZ) informed that the drawing is already approved by screening committee. AA & ES is awaited. Bid for structural consultant, if required will be called by 24.11.2016.

As recommended by CE(RZ) & agreed by EM socio-cultural center of Rohini Zone will be looked after by Sh. A.K. Verma, SE/CC-14 and technical evolution of the same shall be submitted by 25.11.2016.

{Action: CE(RZ) }

A list of issues of Rohini Zone was also handed over by Hon'ble MLA (Copy attached).  
EM, DDA directed to CE(RZ) to resolve each issue in time bound manner.

Next meeting in this regard will be held on 05.12.2016 at 4.00 PM.

3. Sorting out the dispute of handing over the services sewerage etc of Sector-19 to DJB
4. Construction of Community Halls in H-Block, Sector-18 & C-Block, Sector-19, Rohini by DDA. *Sector 15 Rohini*
5. Cleaning of vacant plot in between F-block Park & Govt. Middle (Co-Ed) School, Sector-15, Rohini
6. Construction of Housing on the lands lying vacant in Sector-15, 18 & Sector-19, Rohini.
7. Construction of balance flats of E-1 (Unity Aptt.), Sector-18, Rohini.
8. Allotment/Auction of Commercial plots in Sector-15, Sector-18 & Sector-19, Rohini.
9. Installation of open Gym Equipments in Mahila Park situated in E-block, Sector-18, Rohini.
