## CIRCULAR

Credit Facility to DDA Medical Card Holders by CGHS empanelled hospitals (further taken on DDA panel).

1. Vide No.F2(11)2015-16/MC-II/Pt./56 dt. 07.02.2017, Medical Cell initially circulated approval of 18 hospitals for 'Credit Facility' available to DDA Medical (Working/Pensioners/Family Pensioners/Their Dependents) so that they get cashless treatment for following 04 medical emergencies:-

"Credit Facility will be available only for Heart Dieseases/Heart Attack, Accidnetal cases, Paralytic Attack cases, Respiratory Failure cases, Decompensated Lunge."

2. Vide No. F2(11)2015-16/MC-II/156, dt. 18.08.2017.

As a further welfare measure, Senior Level Committee headed by Finance Member, DDA has further approved 03 hospitals as addition in the list of 18 Credit Facility hospitals (B.L. Kapoor Hospital – Karol Bagh, Park Hospital - Paschim Vihar and Bhagwati Hospital -Rohini), thus making it as 21 Hospitals.

Now (in meeting dt. 28.03.2019) As a further welfare measure, 3. Senior Level Committee headed by Finance Member, DDA has further approved 05 hospitals as addition in the list of Credit Facility hospitals (Venkateshwar Hospital - Dwarka, Aakash Hospital -Dwarka, Park Hospital - Gurgaon, Park Hospital - Faridabad, FIMS Hospital - Sonipat), thus making it as 26 Hospitals.

Above Credit Facility will be subject to following conditions/restrictions/financial checks:-

- (A) The credit limit will be restricted only up to Rs.3.00 lacs per case. After that, due prior permission is to be obtained by hospital in advance.
- (B) Stay in the hospital after 5 days will require prior permission from DDA by hospital.
- (C) 'Credit Facility' will be available only for Heart Diseases/Heart Attack, Accidental cases, Paralytic Attack cases, Respiratory Failure caess, Decompensated Lungs.
- (D) 'Credit Facility' will be restricted to CGHS rates only and hospitals will note that only CGHS rates will be reimbursed by DDA. For any differential treatments/increased rates, stents etc./inplants, the patient(s) will himself/themselves deposit differential cost/amount.
- (E) Hospitals will keep a note on 'Reception' that only Serious Patients with Serious Diseases as defined in the preceding clauses will be entertained for 'Credit Facility'. Minor IPD treatments like Fever, Cataract Operations, Stone Operations etc. will not be offered 'Credit Facility'. However, treatment of 'Serious Diseases' will be available for DDA Card Holders/Their Dependents in the short-listed hospitals on 'Credit Facility' at CGHS rates.

To sum up, following will be the basic condition for credit facility:-

"Credit Facility may be allowed only to those patients who approach Hospital Emergency with major problems relating to Heart Attack, Accidental cases, Paralytic Attack cases, Respiratory Failure cases, Decompensated Lungs, Associated medical treatment such as BP/Sugar etc. will also be treated under Credit Facility."
