The availability of vacancies under 5% Quota for appointment on compassionate ground is 102 Nos, upto 31.12.2018 for the post of MTS, Mali and Security Guard. As per DoPT guidelines 5-B the applicant for compassionate appointment should be eligible and suitable for the post in all respect under the provisions of the relevant recruitment rules. As per recruitment rules for the post of MTS, Mali and Security Guard, erstwhile group-D the minimum qualifications are 10th Pass or equivalent and the age limit for these posts are 18 to 25 years. However the relaxation in the upper age limit and qualification shall be governed by DoPT guidelines.

2. Notification of revised merit points after Seventh Central Pay Commission for assessment of application for appointment on compassionate ground has been issued by MoIIUA vide O.M. No. A-12012/2013 Admin-IV dated 06.08.2018 which has now been adopted by DDA.(Copy enclosed-Annexure 'A') To make part-A to DoPT O.M. No. 14014/02/2012/ESII(D) dated 16.01.2013 complacent to new merit point. The following changes are hereby authorized.

- 5.3 In respect of part III (e) (i) and part III (e)(ii) information (as stated in S.No. 2.2 above), apart from furnishing supporting documents the details shall also be incorporated in affidavit.
- Cases complete in all respect shall be submitted to Personal Branch -5, DDA Room No. 709, 7th Floor B- Block, Vikas Sadan, INA, New Delhi-23, for consideration in screening committee. **Incomplete cases and cases received after last date shall not be entertained** for placing before screening committee. The assessment will be made on the basis of the revised affidavit furnished by applicant.
- An applicant will make only one request against the deceased /medical decategorized in format enclosed as shown in Annexure 'C'.
