As Above to measuring 3000 sq Mtr  
On 18/01/13 for temporary use on the  
following terms & conditions as already accepted.

- The said booking for temporary use as specified above shall not be misused for any other purpose. If any misuse is found at site, the land shall be vacated with force without any notice in the record and DDA shall not be responsible for any damage or loss on this account. In such a scenario, your security deposit shall stand forfeited.
  - The said land shall also be vacated if any risk and cost to the land is encroached or any other such circumstances arise as above. Under such circumstances, DDA shall not be responsible for any damage or loss to your moveable properties. Your security deposit shall also be forfeited in such circumstances.
  - The said booking is not allowed if it is found by the field staff of DDA that temporary booking has been obtained by any means of fraud, or practicing any fraud and or through impersonation. In such a case, the booking so granted shall automatically stand cancelled and you shall be liable for eviction, besides criminal proceedings in forfeiture of your security deposit. DDA shall not be liable for any damage and/or losses sustainable to your goods, such forcible eviction.
- It must be noted that on DDA's property, such as boundary wall, grill fencing, gates, roads and trees etc. shall be damaged. In case of any damage in this regard, your security shall stand forfeited and the recovery of the value of damage.

Condt. 2...

You will have to ensure the fire norms prescribed by the Chief Fire Officer (NCTD), DDA shall have no responsibility of any fire accident or otherwise due to your storkness, carelessness or sheer negligence. (copy enclosed)

No parking vehicle inside the DDA's vacant land is allowed.

You will have to make your own arrangement for water, electricity etc.

Use of loud loud speakers, DJS Musical instruments and Band etc is subject to various Acts/Laws in force and you will have to get permission where it required from the authority concerned.

In case the booking is cancelled due to any reason by you and the intimation of this cancellation is made before one month from the date of function you shall be entitled for 90% and 50% refund if intimation is made before 15 days of function. No refund shall be allowed if the intimation is within 15 days from the date of function. Such refund shall be allowed only on properly written requests and these orders shall be applicable with prospective effect.



DDA reserves the right to cancel the said permission without any notice in case of violation of the said terms and condition.

DDA reserves the right to withdraw permission under forced circumstances without any liability or claim of damages and losses from your side.


If the rate of booking/charges revised upto the date of function the applicant is liable to deposit the increased amount.
