## CIRCULAR NO: 8

Sub: Review of Scheme for Compassionate appointment in the light of the 6<sup>th</sup> Pay Commission recommendations.

In compliance Of Office Memorandum No. F. .No. 14014/2/2009-Estt(D) dated 11<sup>th</sup> December, 2009 issued by the Ministry of Personnel, Public Grievances and Pensions, Deptt. Of Personnel & Training on the above noted subject (copy enclosed) the Competent Authority has decided that the pay of the employees recruited on compassionate grounds shall be regulated as under:-

- 1. In case of those employees/appointees, who do not possess minimum qualification i.e.  $10^{th}$  treat them as trainees till the department gives them necessary training as contained in the  $6^{th}$  CPC report.
- 2. Till the completion of training, they shall draw their salary in Pay Band of Rs. 4440-7440/- without grade pay, but they will be entitled to draw all other allowances suggested by 6th CPC.
- 3. In case of those employees/appointees, who possess prescribed qualification i.e. 10<sup>th</sup> and above, are entitled to draw PB-1 of Rs. 5200-20200 along with grade pay of Rs. 1800/-.
- 4. The period spend spent in PB-1 S will not be counted as service for any purpose as their regular service will start only after they are placed in PB-1 of Rs. 5200/- to 20200/- with grade pay of Rs. 1800/-.
- 5. This will be applicable to all categories of employees/fresh recruits on Compassionate grounds approved by DDA authority vide authority resolution No. 62/2010.
