**OFFICE ORDER**

In view of the performance review of GIS agencies empanelled under PM-UDAY Cell for undertaking GIS surveys of PM-UDAY applications, the Competent Authority has decided to de-empanel seven (7) GIS Survey agencies that had been empaneled with Delhi Development Authority under PM-UDAY vide office order no. PM-UDAY/2019/DDA/GIS/39 dated 24.01.2020. The following agencies shall cease to be empanelled with Delhi Development Authority with immediate effect:

1. M/s. Yashi Consultancy Services Pvt. Ltd.
  2. M/s. Shivom Engineers Associates Pvt. Ltd.
  3. M/s. Gaveshana Geosciences Pvt. Ltd.
  4. M/s. Facile Maven Pvt. Ltd.
  5. M/s. Theodesh Consultants
  6. M/s. CadMax Consultancy (P) Ltd.
  7. M/s. Uneecops Technologies Limited
2. Further, the empanelment of M/s. Geokno India Pvt. Ltd. has not been extended beyond 15.06.2020.
3. The above mentioned eight (8) agencies shall cease to conduct any further surveys from the date of issue of this order. They will complete the data uploading for those cases where they have accepted payment in any sort from the applicants and provide them the GIS ID within seven days from the date of issue of this order. In case, there are certain cases where these agencies have collected payment from applications in advance before conducting the survey, the amount shall be returned to the applicants in those cases by these agencies.
4. Further, the empanelment of the following agencies that had been empaneled with Delhi Development Authority under PM-UDAY vide office order no. PM-UDAY/2019/DDA/GIS/65 dated 16.12.2019 has been extended for another six (6) months w.e.f. 15.06.2020.

  3. M/s. GEOID Consultancy Pvt Ltd.


